8. Planning Clerk's Report

EDFC Licensing is consulting with Local Councils on the District Council's statement of Licensing Policy. The Licensing Act 2003 requires licensing authorities to determine and publish its statement every five years – the current policy was approved in December 2020. The closing date for comments on EFDC's proposed changes to its existing statement is 18th August 2025.

An appeal has been lodged against EFDC refusal of EPF/2531/24 – for a proposed vehicle crossover to serve 39 and 39A Dukes Avenue CM1 7HG

A resident has advised that a Silver Birch tree located to the front of a property in Coppice Row and believed to be the subject of a Tree Preservation Order, has been cut down. The Planning Clerk would report this to the EFDC Trees and Landscape team.

Concerning the recent erection of high fencing around the boundary of a property in Poplar Row: EFDC has advised a resident who raised concerns with them that the occupant of the property in question has been instructed to remove the fencing.

9. To consider a response to the public consultation re. Government proposals to alter the role of planning committees (in England), which could limit the number of decisions scrutinised by locally-elected District Councillors:

23rd July 2025. Concerns were raised that a so-called 'national scheme of delegation' would reduce the role of the elected
Members of a District Council in making decisions on local planning applications in relation to the majority of proposals for
new dwellings, and also remove the right of interested parties, and applicants, to speak at a District Planning Committee. It
was felt that these changes would be undemocratic and would allow for less public scrutiny of decisions made by a Local
Authority. It was agreed that ClIr Burn would draft a response from the Parish Council, for approval by Planning Committee
Members. It was noted that ClIr Amos has responded to this consultation in his role as District Councillor.

10. Any Other Matters relating to Planning, without decision

Cllr Burn raised a concern regarding retention of the cat slide roof set back feature of a property in Dukes Avenue that is in the process of being extended – a large section of the front façade having been completely removed. It was agreed that the Planning Clerk would raise a planning enforcement enquiry with EFDC.
